## PROMOTION REGULATIONS

"Promotion for graduates continuing studies at first-cycle, second-cycle or long-cycle master's degree studies at the Vistula School of Hospitality or at Vistula University"

- 1. The Promotion is addressed to students who have completed full-time or part-time, first- or second-cycle studies (including online studies) or uniform long-cycle master's degree studies at the Vistula School of Hospitality, regardless of their nationality, and wish to continue their education at the Vistula School of Hospitality or at Vistula University (hereinafter referred to as the "University") at first- and secondcycle studies or long-cycle master's degree studies conducted in Polish or English in full-time or parttime mode, including online studies (hereinafter referred to as the "Studies").
- 2. Participation in the Promotion enables the students to obtain the following discounts:
  - PLN 0 recruitment fee,
  - PLN 0 registration fee,
  - 20% discount on the regular tuition fee for each year of studies when continuing education at the Studies referred to in point 1 of the Regulations.
- 3. The discount referred to in point 2 of the Regulations is calculated on the regular amount of the tuition fee payable by students in accordance with the course of Studies for which they have registered.
- 4. Information on the current tuition fees for Studies, including the discount, can be found on the website at: https://vistulahospitality.edu.pl/en/promotion/promotion-for-graduates This information does not constitute an offer within the meaning of Art. 66 of the Civil Code and is provided solely for information purposes.
- 5. In order to meet the eligibility criteria for the Promotion and application of discounts listed in point 2 of these Regulations, the Candidates must complete the following activities by the closing date of the recruitment process for a given academic year:
  - register in the dream apply recruitment system;
  - upload in the recruitment system the following: scans or photos of all documents necessary to continue studies, including a diploma of completing first-cycle studies or a certificate of defending a bachelor's thesis in the event of continuing education at second-cycle studies or a diploma of completing long-cycle master's studies<sup>1</sup>;

<sup>&</sup>lt;sup>1</sup> The documents listed in this point are to be uploaded to the rectruitment system by candidates who already have a diploma of completing first-cycle studies or a certificate of defending a bachelor's thesis in the event of continuing education at the secondcycle studies. Candidates awaiting the defense of their bachelor thesis, in order to participate in the Promotion, complete an online application to which they upload the necessary documents needed to take advantage of the Promotion, and then, immediately after the defense, upload to the recruitment system a scan of the certificate of defense results.

- upload to the recruitment system a scan or photo of the approved Promotion Regulations "Promotion for graduates continuing studies at first-cycle, second-cycle or long-cycle master's degree studies at the Vistula School of Hospitality or at Vistula University";
- pay the annual or semester tuition fee or a tuition fee installment in the 10-installment payment plan in the amount including the discount granted. In the case of a bank transfer, the payment date is the date on which the payment is credited to the University's bank account;
- upload a scan or photo of a document confirming payment of the above-mentioned fee to the recruitment system;
- admission of the applicant to the University.
- The Promotion comes into force on February 12, 2024 and lasts until further notice.
- 7. The Promotion is addressed to **the Vistula School of Hospitality** students.
- 8. The Promotion cannot be combined with any other promotions offered at the Vistula School of Hospitality or at Vistula University.
- 9. If the recruiting person has met the conditions for taking advantage of the Promotion indicated in point 5 of these Regulations, but despite receiving a positive decision on admission to Studies, he/she does not undertake the Studies or if after being admitted to the Studies, he/she is struck off the list of students in the first or subsequent year of Studies, including in connection with the resignation from Studies, the discounts granted under this Promotion shall be canceled in respect of the year of Studies that this person has not completed. In such a situation, the University has the right to charge for the unfinished year of Studies the full tuition fee for the Studies (in all types of payments) in accordance with the regular price for the uncompleted year of Studies, and in the case of the failure to complete the first year of Studies, additionally, the recruitment fee and registration fee.
